

#### Crime

She was instructed as disclosure counsel by the Serious Fraud Office in 2021 and is trusted as led junior by the Crown Prosecution Service. Tayo was placed to the Crown Prosecution Service specialist fraud panel in December 2022.

### Family

Tayo receives instructions in all areas of private and public law children proceedings. She is experienced in complex family disputes, contact cases, domestic violence cases and cases involving non-accidental injuries to a child.
